WHAT IS THIS PRODUCT?

Type

Global Equity is a Sub-Fund of Olympian SICAV (the "Fund"). The Fund consists of separate classes of shares constituting segregated sub-funds which are segregated patrimonies. The Fund is incorporated under the laws of Luxembourg, having its registered office at 11-13 Boulevard de la Foire L-1528 Luxembourg, Grand Duchy of Luxembourg and licensed by the LBR under license number B79640.

Objectives and Investment Policy

The objective of this Sub-Fund is to take advantage of all kinds of international markets opportunities, with a short to medium term investment horizon.

The Sub-Fund will invest mainly in transferable equity securities of large international corporations in all sectors, regions and currencies. The term large international corporations refers to the market capitalisation of companies of minimum Euro 1.000.000.000 (one billion euros).

The allocation of the assets portfolio by sector will be based on the Sub-Fund's appreciation of the economic situation in each sector of activity.

If the conditions on equity markets are unfavourable or not sufficiently attractive, the Sub-Fund may invest in fixed income securities up to 80% of its net assets.

The Sub-Fund shall use financial derivatives instruments as core investment to its investment policy.

The Remaining Assets may be invested to the full extent and within the limits permitted by its Prospectus.

Within the limits set forth in its Prospectus, the Sub-Fund is authorised to use financial techniques and instruments both for hedging and efficient portfolio management purposes.

Benchmark and Strategy

The Sub-Fund does not have a reference benchmark and it is actively managed. The Management Company has full discretion over the composition of the Sub-Fund's portfolio, subject to the investment objective, policy and restrictions stated in the Fund's Prospectus.

Dividend policy

The Sub-Fund does not intend to distribute dividends. Any income arising from the Sub-Fund's investments is reinvested and reflected in the value of your shares. However, the annual general meeting of shareholders may decide to distribute such income.

Term of the Product

The product has been established for an indefinite period of time. You can buy, sell and switch shares in the Sub-Fund by providing instructions within 1 business day prior the Redemption Day as outlined in the prospectus of the Sub-Fund. The Directors may in their excusive discretion limit the total amount of redemptions effected on any Redemption Day to 10% of the outstanding Investor Shares in the Sub-Fund on that day.

Practical Information

The Sub-Fund's depositary bank is CACEIS Investor Services Bank S.A. The NAV is calculated on a daily basis and is published on the Management Company's website. This KID is specific to the Class of the Sub-Fund. However, the Prospectus and the annual, and half-yearly, financial reports are prepared for the entire Fund. These documents are available free of charge, in English, on the Management Company website.

Intended retail investor

The Sub-Fund aims to meet the needs of all types of investors who are willing to hold their investment for a medium term.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cashin at an early stage, and you may get back less.

You may not be able to cash in early. You may have to pay significant extra costs to cash in early. You may not be able to sell your shares in the Sub-Fund easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this Sub-Fund compared to other Funds. It shows how likely it is that the Sub-Fund will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Fund as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the Sub-Fund's capacity to pay you.

Be aware of currency risk. You may receive payments in a different currency to the base currency of the Sub-Fund, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Beside the market risks included in the risk indicator, other risks may affect the Sub-Fund, including counterparty risk, credit risk, liquidity risk, operational risk and investment risk.

This table shows the money you might could get back over the next 5 years, under different scenarios, assuming that you invest EUR 10,000. WHAT HAPPENS IF ABALONE ASSET MANAGEMENT LTD IS UNABLE TO PAY OUT?

This Sub-Fund is a sub-fund of Olympian SICAV, which is a Company organised under the laws of Luxembourg as a multi fund investment company with variable share capital (SICAV). The Company consists of separate classes of shares constituting segregated sub-funds which are segregated patrimonies. The assets of the product are segregated from the assets of Abalone Asset Management Ltd and they are deposited with the depositary. A default of Abalone Asset Management Ltd does not have any impact on the value of your investments in the Sub-Fund.

WHAT ARE THE COSTS?

The person advising on or selling you the Sub-Fund may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you invest in the Sub-Fund and how well the Sub-Fund does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the Sub-Fund performs as shown in the moderate scenario
- EUR 10,000 per year is invested

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 0.4% before costs and 0.3% after costs.

We may share part of the costs with the person selling you the Sub-Fund to cover the services they provide to you. They will inform you of the amount.

Recommended holding period: 5 years
